Notice to Owners, Boatmen and Passengers

A boat shall not ply for hire within the limits of any port unless a license in respect of such boat is issued from this Office. The owner and the boatman in charge of a licensed boat shall not proceed with passengers or goods on board in excess of those permitted and specified in the license. Each boat shall carry adequate lifejackets for the boatmen and passengers permitted to carry on board.

If any boat is found without adequate number of LSA, FFA and other safety items during routine or surprise visits the license of such boat shall be cancelled immediately.

The owners and boatmen are also advised to listen to weather bulletin and meteorological warnings over radio regularly and act as appropriate.

This notice is issued for the safety and awareness of all concerned and shall come into immediate effect.
