Subject: Authorization to Germanischer Lloyd - Chittagong (Bangladesh) for Hull Classification of Coastal Tankers in the Perspective of Bangladesh.

Dear Sir,

With reference to the above mentioned subject we authorize Germanischer Lloyd - Chittagong (Bangladesh) to issue the Certificate for Hull for the Newly Built Coastal Tankers and to the Register these Tankers with Germanischer Lloyd and Administration under the following terms and conditions:-

- 1. Authorization by the Bangladesh Administration to conduct survey and drawing Approval for Hull Parts including welding schemes & NDT tests, in accordance with relating GL Rules with omission of survey and plan Approval of main propulsion Machinery, but all cargo pumps & Machinery, Electrical drawings including pump room are to be submitted to Germanischer Lloyd - for examination. All Electrical Equipments used including intrinsically safe circuits are to have Type Approval from Class.
- 2. Authorization by the Bangladesh Administration to issue the Certificate for Hull for the Newly Built Coastal Oil Tankers under Germanischer Lloyd.
- 3. Authorization by the Bangladesh Administration to issue Freeboard Assignment and Non-Convention Load Line Certificate.
- 4. Authorization by the Bangladesh Administration for Approval of Strength Calculation and Stability Calculation Booklet.
- 5. Authorization by the Bangladesh Administration for tanker ship Safety Construction Certificate associated with relevant equipment.
- The ships built under this special offer shall be restricted to ply only in the Bangladesh Waters.
- 7. To meet the shipyard's qualification satisfied with GL standard.

Compliance with MARPOL Annex-1 provisions:

8. Authorization by the Bangladesh Administration to issue Certificates for MARPOL Annex-1 with omission of oily water separator for these types of tankers.
